Upon investigation, it was discovered that the pressure was low at both pump stations, and water was coming out of the ground on S. Main Street. Sunday evening, Tim A and Tim G cleared off the valves. Tim received another call about pressure dropping again. Due to the water main break, approximately 20 homes were turned off. On Monday morning, the area was dug up and the leak was repaired. A Boil Water Alert was issued to those 20 homes. Samples were sent to the lab. Once both sets of samples passed, the Boil Water Alert was lifted. It took about 3 days for the pressure to return to normal.
